Parent/Guardian Release

I, the parent/guardian of the above-named player, hereby agree to the following while my player participates with Crush:

1. I understand that participation in baseball may result in serious injuries and protective equipment does not prevent all injuries to players.
2. I waive, release, absolve, indemnify, and agree to hold harmless Crush, the organizers, sponsors, supervisors, participants, and persons transporting my/our child to and from activities from any claim arising out of any injury to my child whether the result of negligence or for any other cause.
3. I give my consent for Crush or to the employees, representatives, or agents of Crush Baseball to arrange for all necessary medical treatment for which I shall be financially responsible. This care may be given under whatever conditions are required to preserve the life, limb, or well-being of my dependent.
4. I give my consent to Crush to use photographs, video recordings, and sound recordings of my player for the documentation of the activities of the Crush program. I grant Crush permission to use the negatives, prints, motion pictures, video/audio tapings, or any other reproduction of the same for Crush Baseball educational and promotional purposes in manuals, flyers, the internet, or other publications.
5. I agree to pay for all damages to the facilities of Crush Baseball caused by any negligent, reckless, or willful actions by me, my child, or my family.
6. I agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by Crush Baseball, or the employees, representatives, contractors, or agents of Crush Baseball.
7. My player will respect the differences and abilities of all other players. I understand that bullying or exclusionary behaviors will not be tolerated and may lead to termination from the program without notice or refund. I also understand that if the program determines that my/my family's conduct at team practices or games does not represent the values of Crush, my player may be removed from the program without notice or refund.
8. I understand that Crush does not take all players that try out, roster spots are limited, and that agreeing to play for Crush means that my player is taking one spot of a limited amount. Because of this, I understand that there are no refunds for missed Crush events. Further, I understand that refunds will only be allowed during the first 7-day period that team rosters have been published, and not after the 7th day.
9. My player is committed to only playing for the Crush organization and no other club baseball team (not including Little League). I understand that the Crush program strives to provide a healthy balance of baseball play and rest among our teams and that playing outside of Crush is therefore not allowed unless Crush is notified in advance and agrees that it is in the best interest of the athlete and their team.
10. I understand that after tournament fees have been communicated to the team, there are no refunds, even if my player misses games.
11. I understand that paying program or tournament fees for my player does not guarantee playing time on any team.
12. I understand that there are no refunds for rainouts or cancelations.
13. I understand that the Crush program is not a feeder program for any high school and that playing for Crush will not influence my player's chances of playing for their high school team.

15. I have read the [Matheny Manifesto](#) and I understand that the Crush program intends to model this philosophy.
16. I understand that if any of the above policies are violated for any reason, it may result in my player's termination from the program with no notice or consideration of a refund on program fees.
